### Immigration & Citizenship Status Under Washington State Law Against Discrimination

The Fair Housing Act (FHAct) prohibits discrimination based on: Race, Color, Religion, National Origin, Sex, Disability, and Familial Status. These Protected classes are available in all the fifty (50) states (nationwide). However, many states and local jurisdictions have enacted their own fair housing laws and ordinances which include protected classes not included in the Fair Housing Act. For example, Washington State has protected Marital Status, Creed, Sexual Orientation/ Gender Identity, and Veteran/Military Status. The FHAct and WLAD make it illegal for housing providers to deny housing to potential qualified tenants or buyers because of their protected class. When it comes to the FHA or the WLAD, housing providers cannot treat prospects and tenants differently because of their protected classes.

On June 11, 2020, an amendment to the Washington Law Against Discrimination (WLAD)<sup>1</sup> went into effect prohibiting discrimination based on Immigration and Citizenship status. "Citizenship" refers to a person recognized under the law of a country of belonging to thereof.<sup>2</sup> "Immigration" is defined as the international movement of people to a destination country of which they are not natives or where they do not possess citizenship to settle as permanent residents or naturalized citizens.<sup>3</sup> "National origin", protected by the Fair Housing Act, and WLAD, refers to the country a person was born in or where their ancestors were from; an individual should not be mistreated in housing because of their country of origin, culture, ancestry, linguistic characteristics, accent, or physical appearance.

According to the American Immigration Council, 14 percent of the U.S. population are immigrants. In Washington State, about 13.7 percent of the state's population are immigrants, and 17 percent of self-employed/business owners in Washington State are immigrants. As of 2019, immigrants and refugees made up 5.6 percent of the Spokane County area's overall population.<sup>4</sup>

Under the WLAD, U.S. citizens, noncitizen nationals, asylees, refugees, and recent permanent residents are protected from discrimination in housing. Housing providers should not discriminate against individuals in housing transitions such as renting or buying or because the individuals are or are not U.S. citizens, or because of the individual's immigration status. WLAD makes it illegal for housing providers to discriminate against individuals because they are perceived as looking or sounding to be foreigners/outsiders or to request more or different documents than what they would request from U.S. citizens, or specify certain documents that the potential buyer or renter should present because of their immigration or citizenship status.

- Housing providers should be able to process applications regardless of whether the potential tenant/renter has a social security number or not. The potential tenant could provide alternative identification documentation such a driver's license, passport, or permanent resident card.
- Immigration and citizenship status discrimination may include refusing or delaying making repairs because of a person's immigration or citizenship status.
- If housing providers refuse or delay taking an action when their tenants are being harassed by other tenants because of their immigration or citizenship status might be considered discrimination under the WLAD.
- If an applicant or tenant files a fair housing complaint against a housing provider, the housing providers should not retaliate against that person.
