

My housing situation is “unfair!”

Can Northwest Fair Housing Alliance help me?

- The **Fair Housing Act (FHA)**: is a law that protects you from housing discrimination because of your race, color, national origin, religion, sex, disability or familial status (children in the household).
- NWFHA Advocates can listen, ask questions and help you determine if it is discrimination. Advocates will give you options, provide guidance and share resources so you can assert your rights in housing.
- Unfortunately, many housing situations are “unfair” **but** are not discriminatory. If your housing situation is under the landlord tenant laws, you will need a legal remedy; NWFHA can refer you to free legal services.
- The FHA states persons with disabilities can ask most housing providers for a reasonable accommodation (**RA**) or modification (**RM**) if it is needed because of a disability.
- **If a person with disabilities needs support**, NWFHA Advocates can make RA/RM requests to a housing provider for that person.
- If you believe you are facing housing discrimination, or you were denied a RA/RM request, NWFHA Advocates can help you file a complaint with Housing and Urban Development (HUD). The advocate supports you; explains the steps, discusses evidence, drafts and files the complaint and accompanies you in HUD interviews.

- **Fair Housing Act (FHA)**: ej juon kakien ej kejarok kwe jen mantin kalijeklok ilo imōn jokwe kōnke kwe riia, kalor in kilim, lale eo kwar ejaak jeñe, kabuñ, armej ro rej uwaan baamle eo am (ñe ewōr ajiri rej jokwe ibbam).
- Armej ro rej lelōkn Rōjañ jen NWFHA remaron roñjak ta ko kwōj ba, lewaj kajjitōk, im jibañ ke lale elañe ekkar mantin kalijeklok wāween eo. Armej ro rej lewaj Rōjañ renaj lewaj melele kōn ta ko kwōmaron kōmmāne, lewaj melele im jikin ko remaron lewaj jibañ bwe kwōn maron kōjerbal maron ko am iomwin kakien ikijen imōn jokwe.
- Buromoj, elōñ wāween imōn jokwe ko “rejab jimwe” **bōtab** rejab mantin kalijeklok. Ñe mweo kwōj jokwe e ewōr kakien ko an landlord im armej eo ej reen, kwōnaj aikuj juon jibañ in loar; NWFHA emaron lemaanlok eok ñan jibañ ko jen loar ejellok wonneir.
- FHA ej kalikar ke armej ro ewōr aer nañinmej remaron kajjitōk ibben elōñ jikin ko rej reen im wia kake em bwe ren lelok juon mennin jibañ eo remaron kōtōbrak (reasonable accommodation, **RA**) ak kōmman oktak (**RM**) elañe aikuj kōn juon nañinmej ak utamwe.
- **Ñe juon armej eo ewōr an nañinmej ak utamwe aikuj jibañ**, Armej ro rej Rōjañ ikijen NWFHA remaron kōmmāne kajjitōk ko ikijen RA/RM ñan armej eo ej lelok imōn reen ikijen armej eo.
- Ñe kwōj tōmak rej lewaj mantin kalijeklok ilo mweo kwōj jokwe ie, ak rekkar jab kōtōbrak kajjitōk in RA/RM eo am, Armej ro rej Rōjañ ikijen NWFHA remaron jibañ kwe bael e juon abnōnō ibben Opij eo ej Kakien Imōn Jokwe im Ekāl ilo Jikin ko Relab (Housing and Urban Development, HUD).
